RE: Panasonic Toughbooks RFP #2024-0003

RFP #2024-0003 was released on January 26, 2024. The purpose of the RFP was to solicit proposals from qualified vendors to replace our aging fleet of Panasonic CF-20 Toughbooks, which are used by Paramedics and EMTs to complete electronic healthcare records. Our current Toughbooks are approaching five years old and will soon be outside their warranty period and reach the end of their service lifespan. Panasonic Toughbooks are rugged laptop computers that are used in the field 24 hours per day and 7 days per week. The Toughbooks are placed under extreme environmental conditions and, when paired with Panasonic's Ultimate Care Protection plan, offer the most reliable and cost-effective solution for EMSA's needs. EMSA received four qualified bids.

It is my recommendation to award the contract to CDW. Since Panasonic provides service and provisioning, there are few advantages other than price when selecting a vendor to fulfill this contract. CDW is one of the largest nationwide technology vendors and has submitted the lowest-cost proposal.
